<u>Notice Concerning Cancellation of Issuance of New Investment Units and</u> <u>Secondary Offering of Investment Units</u>

BLife Investment Corporation ("BLife") announces its decision today regarding issuance of new investment units (primary offering), secondary offering of investment units (secondary offering through over-allotment) and issuance of new investment units by way of third-party allotment for which resolution was passed at a meeting of the board of directors of BLife held on September 5, 2011 (collectively referred to as the "Offerings"), to cancel all of these.
