Daiwa House Residential Investment Corporation ("DHI") announces that, at a meeting of the board of directors held today, the following resolution was passed concerning the asset management agreement executed with Daiwa House Asset Management Co., Ltd., the asset manager to which DHI entrusts the management of its assets, on June 7, 2005 (as amended; the "Agreement") to execute an agreement on amendments to the Agreement, with approval of the proposal pertaining to partial amendments to the Articles of Incorporation at the general meeting of unitholders of DHI scheduled to be held on November 25, 2015 as a condition precedent.

- (1) Alignment with the statements of "Chapter 6: Scope and Policy of Asset Management" and "Attachment: Asset Management Fee Payable to the Asset Manager" of the Articles of Incorporation of DHI (to be revised on November 25, 2015) is being made.
- (2) In addition to the above, organization of the text, change and clarification of the expressions, revision of the wording, etc. are being made.
